to receive all movables in the above Safe Deposit Locker and or the monies lying to the credit of the aforesaid Account in the event of my death and I understand that such nomination shall take effect upon my death notwithstanding anything to the contrary declared in any Last will or writing of a testamentary nature heretofore or hereinafter made by me and that this nomination shall be subject to the Laws of Sri Lanka.

This nomination revokes any previous nominations made by me and shall be in force until I expressly revoke it by notice in writing delivered to you or by subsequent nomination made duly by me.

I declare that the payment of the balance in the aforesaid Account at the date of my death by the Bank to the nominee/s referred to herein shall be full and complete discharge of the obligation of the Bank in respect of such Account as provided in section 544 (5) of the said Act.

You are entitled without any notice to me/my heirs to settle my indebtedness to the Bank whether such liabilities be actual or contingent, primary or collateral and several or joint on one account by transferring monies from the credit balance of another notwithstanding the balance on such other accounts and the liabilities may not be expressed in the same currency. The Bank's right will not be affected by my bankruptcy or death.

**Terms and Conditions**

- Subject to the applicable laws and the Bank's general right of set off, the nomination shall have effect notwithstanding anything to the contrary contained in any Last Will of the Account holder/Safe Deposit Locker Holder
- The nomination will stand revoked under the following circumstances
  - on the death of the nominee in the life time of the Account holder/Safety Deposit Locker holder
  - by written notice of revocation of the nomination by the Account holder/Safety Deposit Locker holder
  - by subsequent nomination duly made by the Account holder /Safety Deposit Locker holder and delivered to the Bank
- The funds/movables will be paid to the person/persons legally entitled thereto after legal procedure in the event this nomination cannot be given effect to.
- Payment will be made to a nominee only on production of proof of identity and the Bank reserves the right to call any information /documents that may be required by the Bank, to establish such identity.
- In the case of a nomination of a Safe Deposit Locker, the movables deposited therein would be delivered to a nominee only on production of proof of identity and the Bank reserves the right to call for any information /documents that may be required by the Bank, to establish such identity.
- In the event of there being more than one nominee and no proportion for distribution is indicated, the monies lying to the credit/contents of the Safety Deposit Locker will be paid/delivered to the nominees in equal shares.
- The signature of the Account holder / Safety Deposit Locker holder should be witnessed by two persons one of whom shall be an Attorney-at-Law, Justice of Peace, Qualified Medical Practitioner, or Government Official who is drawing a salary of not less than Rs. 60,000/- per annum. The said witness should affix his seal of office.
